

National PVA's Washington Update

House Takes Action on Clothing Allowance Legislation

The House is preparing to vote on H.R. 4772, the Mark O'Brien VA Clothing Allowance Improvement Act. This important legislation would make clothing allowance payments automatic until the VA determines the veteran is no longer eligible to receive the benefit. If the legislation passes the House, it will then go to the Senate for further consideration. The Senate companion bill to this legislation is S. 2513, the Brian Neuman VA Clothing Allowance Improvement Act. Please contact your senators about this legislation by clicking here.

PVA Testifies at House Hearing on Improving Access to Air Travel

On November 17, the House Transportation and Infrastructure, Aviation Subcommittee held a hearing titled, "Accessible Air Travel: Addressing Challenges for Passengers with Disabilities." The hearing featured testimony from Rep. Jim Langevin (D-RI) who is retiring this year and is the sponsor for the Air Carrier Access Amendments Act (H.R. 1696). Rep. Langevin spoke of the difficulties he has encountered as a wheelchair user in air travel and the need for reform.

Heather Ansley, Associate Executive Director of Government Relations, testified on behalf of PVA. Ms. Ansley noted that the major problem with commercial air travel is that aircraft are required to have very few accessible features. She urged Congress to make systemic improvements in air travel in the next FAA Reauthorization by including the Air Carrier Access Amendments Act. She also called on Congress to include language directing appropriate agencies and administrations to take the next steps as outlined in a September 2021 report on in cabin wheelchair restraint systems.

Other witnesses included Brian Ryks, Executive Director and CEO Metropolitan Airports Commission (Minneapolis/St. Paul) on behalf of Airports Council International—North America; Matt Scott, Paralympian, Team USA; Heather Krause, Director, Physical Infrastructure, Government Accountability Office; and Graham Keithley, Vice President and Associate General Counsel, Airlines for America. Meet Adi Thampi – a Sergeant of Marines and combat veteran. Adi first connected with PVA's Veterans Career Program in 2020 after completing law degree. He worked with our Employment Specialist, Taylor Scott, on his job search, resume writing and interview skills; and eventually relocated to the DC

area to work for a Veteran Service Organization (VSO).

In early 2022, our Vocational Rehabilitation Counselor, Danielle Hetu, reached out to Adi to let him know about staff turnover and how to how to reach out if he needed assistance. He was working for another VSO, and while he found the work very rewarding he also wanted to look at advancement. They updated his resume, drafted new cover letters, reviewed LinkedIn content, and had meetings to discuss applications,

Adi had worked tirelessly on the PACT ACT and was part of the big push to get it passed. Soon after, he was offered the position of Legislative Counselor and Senior Associate at Iraq and Afghanistan Veterans of America (IAVA) and will be starting in December 2022.

Having a month off in between jobs would have likely been a nice break; however, Adi wanted to do something physical that would be "good for his heart". He has been in Florida the past few weeks with Team Rubicon cleaning up and rebuilding after










About Us
