# National PVA's Washington Update

#### Nominee Announced for VA Under Secretary for Benefits

On January 23, the President announced the nomination of Joshua Jacobs to be VA's next Under Secretary for Benefits. If confirmed, Mr. Jacobs, who is already serving in an interim capacity as the Veterans Benefits Administration's (VBA) leader, would lead more than 25,000 VBA employees in the delivery of non-medical benefits programs. VBA provides disability compensation benefits to nearly six million veterans and their survivors and administers pension benefits for over 350,000 veterans and their survivors. Prior to rejoining VA in 2021, Jacobs was a Senior Associate at Booz Allen Hamilton. Jacobs also served as Senior Advisor in the Office of the VA Secretary during the Obama Administration. The next step will be for the Senate Veterans' Affairs Committee to hold a nomination hearing.

#### Medical Providers Agree to Provide Wheelchair Transfer Services

The U.S. Department of Justice (DOJ) settled with Barnett Dulaney Perkins Eye Centers (BDP) and American Vision Partners (AVP) based on a lawsuit alleging the eye surgery providers refused to provide services to patients needing wheelchair transfer assistance. In December 2021, DOJ sued BDP, who operates 24 locations, alleging the eye surgery provider refused transfer assistance to wheelchair users, in violation of the Americans with Disabilities Act (ADA). According to the complaint, BDP required patients to hire third-party medical support personnel to transport them to and from BDP's facilities and provide transfer assistance using gurneys or stretchers, which patients were required to remain on during surgery. In April 2022, DOJ amended the complaint to add AVP and claimed the providers even outright denied patients needing transfer assistance.

Under the settlement agreement, the medical providers must end their policy of denying patients needing transfer assistance. BDP and AVP must also engage in an interactive process with patients to discuss transfer assistance options and give consideration to the patient's preference. If a patient needs third-party transfer assistance, the provider must pay for it. In addition, the providers are required to disclose which locations have accessible medical equipment and train staff on safe transfer techniques.



### **PVA VETERANS CAREER PROGRAM UPDATE**

#### "Resilience is Silent and Deep."



Gwen Banks is an Army retired senior leader and combat veteran with a service-connected disability of 100%. Since serving over 20 years in the military, she was unfamiliar with the civilian employment process but began networking to gain more understanding. One of her contacts, another Veteran Career

Program (VCP) client, referred Gwen to VCP's Employment Analyst, Rodney Lee. Shortly thereafter, Rodney and Gwen began working together.

Gwen knew that after receiving her MBA and with the human resource and operations experience she had gained, she wanted to pursue leadership roles in HR or business operations. They explored positions together from organizations that the VCP is partnered and connected with for meaningful opportunities that were close fits with her interest and qualifications. They began revising and tailoring her resume in preparation to start applying to positions once she was within six weeks of her military transition.

During this time, Gwen was involved with networking, researching organizations, building her LinkedIn profile, and revising several drafts of her resume. Due to her obvious leadership abilities and experience, Rodney introduced Gwen to an executive MBA development program for transitioning military leaders, and the executive over it. After piquing the interest of the program leader from their initial discussion, Gwen was invited to interview with Bank of America.

After interview preparations and mock interviews, Gwen went on to conduct four interviews with the bank and was selected and invited to join the organization in the February 2023 cohort. Gwen will begin her new career

The average salary for the 13 clients placed in fulltime employment was \$64,145; and the average income for the 3 clients placed in part-time work was \$29,360.

In 2022, the Veterans Career Program placed a total of 221 clients: 199 are veterans, 20 family members, 4 caregivers; 32 are PVA members and 12 are PVA member-eligible.

- The average salary for full-time employment in 2022 was \$63,856; and the average income for part-time employment in 2022 was \$17,945.
  - Paid Employment: 167
  - Training/Educational: 42
  - Volunteer: 12

Also in 2022, we hosted a total of 82 Veterans Career Live informational sessions (36 career skills, 21 employer sessions, 13 education, 10 small business and 2 health/wellness) with 8,882 registrants and 2,835 live attendees (for a 32% conversion rate). Our attendees were 93% veterans, 3% military spouses, 2% caregivers and 2% employers/agencies.
